AS 1102 Air Force ROTC General Military Course Leadership Lab	Tabled	 Update the course description to reflect the change to two hours laboratory. Remove the prerequisite as it is currently formatted as this is not enforceable in Banner. Instead, clarify that the course is restricted to AFROTC cadets as a final line in the course description. Rewrite the Course Learning Outcomes to align with Bloom's taxonomy and make them consistent between the CIM and syllabus. Add a fourth Course Learning Outcome. Update the weekly contact time in the CIM and on the course calendar to show two hours instead of four. Review and update the repeatability and max credits to align with proposed contact time and credit hour production. In the course calendar, show 100 minutes per week for 15 weeks, for a total of 1,500 minutes. Replace outdated policies with University Syllabus language and link. Confirm that AFROTC-specific policies are still current. Provide an updated letter of support.

CO 2933 Intro to Digital Video Production	Passed- Contingent	 Consider slightly rewording the end of the catalog description. The Course Learning Outcomes in the CIM need to be carried over to the syllabus. Update the weekly contact time in the CIM to show 2 lecture, 2 lab (remove 0). Remove the italicized course number and title from the catalog description in the syllabus. In the Attendance section where absence penalties are discussed, clarify that this only applies to unexcused absences. In the course calendar, remove "lecture" from the listings of indirect minutes. In references to time, change CST to CT. Consider including all required materials in Bulldog Bundle.
CO 3943 Non-Linear Editing & Motion Graphics	Passed- Contingent	 The use of commas and semicolons in the catalog description are inconsistent across the CIM and syllabus. Update the weekly contact time in the CIM to show 2 lecture, 2 lab (remove 0).

		 Remove the italicized course number and title from the catalog description in the syllabus. In the Attendance section where absence penalties are discussed, clarify that this only applies to unexcused absences. In the course calendar, remove "lecture" from the listings of indirect minutes. FL 2133 Understanding American Culture Through Monsters	Passed	 The committee recommends submitting the syllabus in PDF format only. Consider seeking a letter of support from EN. No requested edits; <i>one vote to table</i>.
FL 4233 Linguistics for World Language Teachers	Passed- Contingent	 Remove the recommended prerequisites from the CIM, though they can be shared as an additional description in the syllabus. Remove the extra "3" in the third Course Learning Outcome in the CIM. Remove old syllabus; include revised syllabus only.
FL 8423 Language Contact in the Americas	Passed- Contingent	Show the final exam period as a separate 180 direct minutes, during which time the paper is due.
HI 4663 History of Artificial Intelligence	Passed- Contingent	 The course description in the CIM is missing "Three hours lecture." Rephrase "midterms" to just "exams" to reduce opportunity for confusion.
MA 1213 Math in Your World	Passed- Contingent	 The course descriptions in the CIM and syllabus are slightly different. Swap the placement of "Three hours lecture" and the prerequisites in catalog description. In the Course Purpose section, the MAA link is broken. Also, clarify that this "text" is not the textbook. Include percentages for all assignments in the extended assignment descriptions.
MA 2113 Elementary Statistics	Passed- Contingent	 In the syllabus, retitle "Requirements" to "Course Description." Update all references to the course title to reflect the proposed title (see "Course Assignments" section) or remove if not necessary for clarity. Correct the possible points for the three tests to show as 130 points each.

PH 4163/6163 Foundations of Quantum Computing	Passed- Contingent	 In the third Course Learning Outcome, edit slightly to show "quantum <i>computing</i> algorithms" on the syllabus and in the CIM. Remove the 180 direct minutes for the final from the total; list separately.
PS 4673/6673 Intelligence and International Affairs	Passed- Contingent	 Update the effective term in the CIM to Spring 2026. Remove "grade of D or higher" in the course description in the CIM and syllabus. Label the text's ISBN numbers as such. The link on Week 1 of the course calendar is broken.
MA/ST 2113 Elementary Statistics	Passed- Contingent	 In the syllabus, retitle "Requirements" to "Course Description." Update all references to the course title to reflect the proposed title (see "Course Assignments" section) or remove if not necessary for clarity.
